Sealed tenders affixing Court Fees Stamp of Rs. 8.25 are invited from intending Registered Firms for Annual Maintenance Contract for **17 Water Cooler & Water Purifiers** in the Assam Secretariat Complex for a period of one year. The tenders will be received upto **2.00 P.M. of 17/2/2017** and will be opened at **3.00 P.M.** on the same date. The tender should be submitted by the tenderer in **2 (two) bids** in Separate Envelopes. One envelope shall contain only relevant documents along with technical specification(Technical bid) including the **Rs.3000/-(Rupees three thousand)** only as earnest money in the form of NSC which is to be pledged in favor of Secretary to the Govt. of Assam, Sectt. Admn. Department. The other envelope (Financial bid) should contain only quoted amount for AMC. The two separate envelopes should be boldly written as "**Technical Bid**" and "**Financial Bid**".

Technical Bid should carry the following :

- An application stating the offer of tender and signed copy of General Terms & Conditions.

 2. VAT Registration Certificate, VAT Clearance Certificates & TIN etc., if any where applicable.
 3. An amount of Rs.3000/- (Rupees three thousand) only as earnest money in the form of N.S.C. to be duly pledged in favor of the Commissioner & Secretary to the Govt. of Assam, Sectt. Admn. Deptt. may be furnished along with tender.
 4. VAT should be shown clearly if any where applicable.
 5. Trade Licence from competent authority




