In Accordance with Sections 84, 85 & 89 of the Electricity Act, 2003, Government of Assam invites applications for the post of Chairperson, Assam Electricity Regulatory Commission (AERC) from persons who meet the following criteria :-

1. The person shall be of ability, integrity and standing who has adequate discerning knowledge of and has shown capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management.
2. The person should not have any financial or other interest with any corporate entity dealing with generation, transmission, trading and distribution of electricity in Assam, which is likely to affect prejudicially his or her function as Member of the Commission. The person must give a certificate to this effect while applying for this post.
3. The Chairperson shall hold Office for a term of five years from the date he enters upon his Office or till he attains the age of 65 (sixty five) years, whichever is earlier.
4. The Chairperson shall receive a fixed pay of Rs.80,000/- plus special allowance of Rs.1000/- only per month and such other allowances as notified by Govt. of Assam Vide No. PEL.222/2005/Pt.I/153, dated 05.02.2011, or as may be notified by the state government from time to time.
5. The Selection Committee constituted as per the provision of the Electricity Act, 2003 for the purpose of making the selection to the post of Chairperson, reserve the right to consider and recommend any other person fulfilling the criteria laid down in the Act for the post of the Chairperson apart from those who have applied against this advertisement. The Head Quarter of Assam Electricity Regulatory Commission is in Guwahati.
