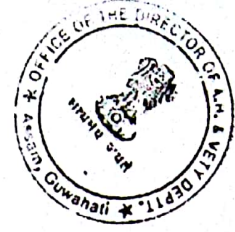

- Prevention of Cruelty to Animal Act. 1960.
- Other Rules, Regulation, due Govt. procedures prevalent and in force when even required.


