1. Forwarding letter on the 'letter head' of the bidder with seal & signature affixing court fee stamp of Rs. 8.25 (Rupees eight and twenty five paise) only on the top.
2. An amount of Rs. 5000/- (Rupees five thousand) only as Earnest Money Deposit in the form of NSC/Bank Draft to be pledged in favour of Secretary/Commissioner & Secretary to the Govt. of Assam, SAD.
3. Firm Registration Certificate/Registration of Sole proprietorship.
4. Valid VAT Registration Certificate.
5. Trade Licence.
6. A food safety certificate from competent officers of Health & Family Welfare Department, Govt. of Assam.
7. Signed copy of terms & conditions of the NIT.

**The Financial Bid of each tender should contain the following :**

1. The Rate Schedule, quoting the rates (both in figures and words) of each item against Category I, II and III for light refreshment [as specified by the Govt. in Annexure-'A']

Tenders will be summarily rejected in the absence of the above.

Tenders submitted, not in conformity with the above terms and conditions and having erases, overwriting etc. will also be rejected.
