ORDER

Seen and perused the order vide Memo.No.VFV.82/2018/Pt/130, dated 22-02-2019 purported to have been issued by the Joint Secretary to the Govt. of Assam, A.H. & Veterinary Department, Dispur, Guwahati-6 and found to have been issued to the officials like Commissioner & Secretary/ District Magistrate/ Inspector General/S.Ps/Transport officers etc. of various States of India as well as to the officers of the State of Assam.

This is prima-facie a fake order issued in the name of one M/S A.K. Mandal Enterprise, Guwahati, Assam by allowing them to restart their inter-state cattle etc. transportation business as this Department i.e. A.H. & Veterinary Department, Govt. of Assam neither maintaining any such file nor issued any such order.

Since the order in question is not issued by A.H. & Veterinary Department, hence, an FIR has already been lodged with Dispur Police Station and a case has been registered accordingly.

Therefore, all concerned are hereby requested to kindly take note of the same and to contact with the Dispur Police Station, Guwahati-6, Kamrup (M), Assam in the FIR No.1038/19, IPC. Sec.468 if anybody is found practising cattle transportation on the strength of the said fake order.
