**DETAIL NOTICE INVITING RE-TENDER**

The Managing Director, Housefed, Assam, Guwahati-6 invites re-tender from Housefed Empanelled Class-I (A), I (B) & I (C) Contractors with Bid Price for the works detailed below with a validity of 180 (one hundred eighty) days from the date of opening of the tender.

2. The Contractors / Bidders must be registered with the e-tendering system provider for participating in the bidding process. The Bidding document may be downloaded through the portal [www.assamtenders.gov.in](http://www.assamtenders.gov.in) by using their own user ID.

3. Online submission of Technical & Financial Bid is mandatory. Manual submission (without online submission) of bid will be considered as non responsive. Bidders are to submit the required papers for technical bid by scanning and uploading the same before the expiry of the Sequence-'Bid submission' in the activity schedule mentioned below at SI-6.

4. The bidder shall submit the cost of the bid document in the form of Demand draft/Banker's cheque of any nationalized Bank/ Scheduled Bank in favour of "**Managing Director, Housefed, Assam**" payable at Guwahati. Bidders submitting DD/ Banker's Check as cost of bid shall upload the scanned images of the same with the technical bid.

5. The bid security shall be pledged in favour of the **Managing Director, Housefed, Assam** in one of the following forms:

- a) Bank Guarantee from any Nationalized/Scheduled Indian Bank in favour of the concerned Managing Director, Housefed, Assam. (A written confirmation in the Bank's letter head confirming the authenticity of the Guarantee shall be furnished along with the Guarantee).
- b) Fixed Deposit Receipt issued by any Nationalized /Schedule Indian Bank or a foreign Bank approved by R.B.I., acceptable to the employer.

Bank guarantees (and other instruments having fixed validity) issued as security for the bid shall be valid for **45 days** beyond the validity of the bid.
