ORDERS BY THE GOVERNOR OF ASSAM NOTIFICATION

In addition to the earlier notification issued vide No.HLA 248/2020/35 dated 23rd March, 2020 in respect of "Complete Safety Restrictions", the following services are also exempted from the purview of the said notification:

- (i) Transportation and sale (wholesale/retail) of animal feed, animal feed inputs material including maize and soya, veterinary medicines and animal vaccines (wholesale /retail) and administration/dispensing of veterinary medicines/vaccines, after due verification and inspection by authorized officials, only at limited notified places in the district by the Deputy Commissioner concerned.
- (ii) All support staff and workforce of all medicine/ surgicals/ consumables/ disinfectants/ equipments/ medical furniture/ bed net/linens- distributors, C&F and transporters of these are also exempted from the safety restrictions to maintain uninterrupted supply to Government as well as private hospitals & private pharmacies in the state.
- (iii) Officials of UNICEF, WHO, UNDP and JHPIEGO along with their associated consultants and support staff for their health related duties.
- (iv) Operations of Food Corporation of India.
- (v) Only the essential operations of Oil India Limited, Coal India Limited and GAIL.
- (vi) Operations of Railways, Road Transport, Air Cargo and Waterways only for movement of essential commodities.
- (vii) All warehousing, storage and labour activities relating only to essential commodities.
- (viii) News paper hawkers only for the distribution of newspapers.
- (ix) For the purpose of this exemption, essential commodities also include milk (only within local market area).
