The bidder shall submit the cost of the bid document in the form of Demand draft/Banker's cheque of any nationalized Bank/ Scheduled Bank in favour of "**Managing Director, Housefed, Assam**" payable at Guwahati. Bidders submitting DD/ Banker's Check as cost of bid shall upload the scanned images of the same with the technical bid.

5. The bid security shall be pledged in favour of the **Managing Director, Housefed, Assam** in one of the following forms:

- Bank Guarantee from any Nationalized/Scheduled Indian Bank in favour of the concerned Managing Director, Housefed, Assam. (A written confirmation in the Bank's letter head confirming the authenticity of the Guarantee shall be furnished along with the Guarantee).
- Fixed Deposit Receipt issued by any Nationalized /Schedule Indian Bank or a foreign Bank approved by R.B.I., acceptable to the employer.

Bank guarantees (and other instruments having fixed validity) issued as security for the bid shall be valid for **45 days** beyond the validity of the bid.

The bidder shall upload a scanned image of the bid security with the Technical Bid.
