This is for information of all concerned that the provisional Answer Keys for Paper I (HSLC or equivalent examination passed and HSLC or equivalent examination passed along with ITI passed level posts) and Paper II (Read up to Class VIII level posts) of ADRE-2024 under State Level Recruitment Commission for Class IV Posts was uploaded in the website of ASSEB, Div-I on 15-11-2024 and challenges (if any) against the provisional Answer Keys were invited through an online portal in the same website from 15-11-2024 to 28-11-2024 as per Commission's Notice No. SLRC-G-IV/Assam/Advertisement for Analogous posts-IV/2023-24/01/110 dated 13-11-2024.

In case of Paper I, no objection was received against the Provisional Answer keys in the portal. In-case of Paper II, objections were received against Answer keys for four questions.

A Committee of the Academic Experts was constituted by State Level Recruitment Commission for Class IV posts vide order No. SLRC-G-IV/Assam/SEBA Correspondence/2023-24/01/129 dated 19-11-2024 to examine such objections.

Accordingly, the objections raised were placed before the Committee of the Academic Experts. The Committee, after a detailed discussion in its meeting, concluded that the objections have no merit to be accepted and hence, the Committee unanimously rejected the objections.

Thus, the Answer Keys pertaining to Paper I and Paper II released earlier are final and will remain unchanged.
